

Resolution to Add 4 members to the Community Child Protection Team (CCPT)

SUBJECT AREA: Appointments

ACTION REQUESTED:

Pender County's Community Child Protection Team would like County Commissioners approval to add the following members: Jackie Williams of Pender County DSS; Donna Yalch of Lake Wacammaw Boys & Girls Home; Debbie Bell of Parent Corps and Connie Carr-Costin of Pender County Partnership for Children.

HISTORY/BACKGROUND:

County Departments of Social Services are required by statute to provide Child Protective Services. The Community Child Protection Team is a community team, not a Department of Social Services Team. Recognizing that children as bridges to the future will determine the state of society, and being aware that the experiences of each child determines the whole persona of a child, the Community Child Protection Team identifies dynamics within communities that cause children to be at risk of harm. The CCPT advocates for eradication of unsafe environmental conditions and works to eliminate unsafe conditions that impact child wellbeing.


EVALUATION:

Community Child Protection Teams (CCPT) were established as one means for the state and local communities to form a partnership to strengthen child protection. CCPT's were established in response to Executive Order 142 in May of 1991. The duties and responsibilities of the CCPT were adopted as North Carolina Administrative Code 41I.0400. The original purpose and composition of the team was further formalized and expanded by G.S. 7B 1406, effective July 1, 1993. The current members of the Team are:
